Victoria Hayes Four Points by Sheraton 101 Fantasy Harbor Blvd. Myrtle Beach, SC 29579

Re: Requests of on-site video of Dec. 4, 2022, assault

Ms. Hayes:

On the evening of December 4<sup>th</sup>, 2022, I had pulled up in front of the entrance doors of Four Points by Sheraton. I had just left the parking lot of The Boathouse, and pulled over to the lit parking lot for safety.

At approximately, 7:15 p.m. on December 4<sup>th</sup>, as I was sitting in my car in front of the hotel entrance, three vehicles driven by three men, Michael Connett, Robert Visconti, and Gerald Shea, pulled in front of me, behind me, and one was on Fantasy Boulevard blocking my exit from the hotel.

After I was also attacked by two of these men further down Fantasy Boulevard, I called the police. I waited for the police at the local Circle K. I was told to file a police report online, which I did several times. After the incident, me, and two friends physically walked into Four Points, explained what happened, and requested the video of the outside of the hotel during the time of the assault. I was told I had to obtain a police report. It took over four weeks to obtain the police report, because I kept getting notices back that it "Is Not in Our Jurisdiction", but apparently it is in the Horry County Police Department jurisdiction, because I received a card from the police officer with the information of who to contact.

I finally received a police report. I contacted Four Points, spoke with you and others, and requested the video. Yet there still is no response whatsoever. Then a person that I know is apparently "friends" with someone related to Four Points, they were told that there isn't a video. I find that questionable, because we asked for a video the evening of the incident, and at least ten times following the incident. It is also questionable that as soon as I have the police report, I am told there is not a video.

I spoke with an attorney last week and was advised to make one last request in writing for the video on the date of the assault. This is my written request for that video, again.

If this issue is ignored again, I will seek further legal action.
